This report uses census data from the U.S. Census Bureau to describe the growth of the Latino, non-Latino, and total population since 1980. In the following pages, three comparisons are presented. First, Nebraska with its neighboring states; second, the 15 states that have had the largest growth of the Latino population in this period; and third, the counties that are part of the Omaha-Council Bluffs Metropolitan Area. The figures in this report describe two periods, first, the population growth in the entire 1980-2020 period followed by the growth in the last decade (2010 – 2020). In the Annex, there are available tables that include the population for each census between 1980 and 2020, as well as the absolute and percentage growth between each decade and from 1980 to 2020.

Latino Population Growth in Nebraska and the Surrounding States




Figure 1b: Percentage of Total Population Growth that is due to Latino Population Growth for Nebraska and Surrounding States 1980 – 2020 and 2010 – 2020

As Figure 1a in the following page shows, over the past 40 years (1980-2020), the Latino population grew more than double the rate in Nebraska (738%) and Iowa (746%) compared to the United States (325%). In contrast, the total population grew more than 20 percentage points in the United States (46%) compared to Nebraska (25%). Iowa had the smallest total population growth of the states analyzed here at 10%. Among the surrounding states, Colorado saw the largest growth in its total population (99.8%) in this period, but the smallest growth in its Latino population (271.9%) out of the nine states described. Furthermore, Minnesota had the largest growth in its Latino population (976%) and the second largest growth in its total population (40%) of the states. The Dakotas also have a significant growth in its Latino population, but the Latino population in the early 1980s was only about 4,000 people in each state, more than 20,000 people less than any of the other states at that time (Table A1a and A1b in the Annex).

In absolute numbers the growth is significant. The Latino population in the United States grew almost 50 million people (Table A1b in the Annex). Nebraska grew over 200,000 people and Iowa 190,000. Colorado was the state that added the largest number of Latinos, almost 1 million Latinos moved to that state between 1980 and 2020.

Measured as the percentage between the absolute growth of the Latino population over the absolute total population growth, the Latino population has been extremely important in the overall growth of the United States in these last 40 years. About 45% of the total growth of the country is due to the growth in the Latino population (Figure 1b and Table A1c in the Annex). In Nebraska, the growth of the Latino population represents more than half of the total growth of the population, and in Iowa represents over two-thirds. Except for Kansas, in every other state the growth of the Latino population is less than half the total growth of the state. In Kansas, the Latino population represents about 56% of the state's population growth.




Figure 1c: Percentage Change of Latino, Non-Latino, and Total Population for Nebraska and

The last ten years show that the Latino population has grown at similar rates in Nebraska (40%) and Iowa (about 43%), a significant higher growth than the Latino population in the United States which grew only 23% (Figure 1c). The total and the non-Latino populations in Nebraska, however, grew almost the same as the entire country, while in Iowa the percentage growth of the non-Latino and the total population were almost half those of the United States as a whole. Besides Nebraska and Iowa, the three other surroundings states with a growth rate above 40% for the Latino population during the 2010 - 2020 period were Missouri (43%), North Dakota (148%), and South Dakota (75%). The total population growth rates were smaller with 3%, 16%, and 9%, respectively. Although the Latino populations in North and South Dakota had the most growth from 2010 - 2020, their Latino populations were among the smallest of these nine states. The Dakotas and Wyoming are the only states that have a population of less than 100,000 Latinos, but while about 60,000 Latinos live in Wyoming, only about 39,000 live in South Dakota and less than 34,000 live in North Dakota.

The 2010 – 2020 decade, however, shows a decrease in the growth pace of the Latino population (Table A1b in the Annex). Except for North Dakota, the growth of the Latino population between 2010 and 2020 was on average about 30 percentage points less than in the 2000 – 2010 period and about 67 percentage points lower than between 1990 and 2000: the period with the largest growth among the Latino population.

Still, as Figure 1b above shows, the growth of the Latino population between 2010 and 2020 represented more than 50% of the total population growth in three States and the entire country and between 19% and 50% in the other six states analyzed.

Latino Population Growth in 15 Counties of Nebraska

As of 2020, 90% of the Latino population resided within 15 counties in Nebraska (Table 2 and Table A2a in the annex). During the past 40 years (1980 - 2020), the Latino population in these 15 counties grew almost 800%, slightly more than the growth of the total Latino population. Non-Latinos, on the

other hand, grew only close to 28% in these counties and its population decreased by almost 18% in the rest of the counties. Overall, Latinos were responsible for about 40% of the population growth in the 15 counties, while in the rest of the counties the non-Latino population lost close to 96,000 people, Latinos reduced the negative population growth of those counties by over 19,000 people. The last 10 years (2010 - 2020) show a slower growth of the Latino population in Nebraska, albeit still positive.

Within Nebraska, most Latinos in 2020 lived in Douglas County, Lancaster County, Sarpy County, and Hall County (Table 2a and Table A2a in the annex). Overall, Douglas County had the largest number of Latinos at 80,820, even though this represents only about 14% of the total population. In relative terms, Colfax County (47%), Dakota County (41%), Dawson County (36%), and Hall County (31%) have the largest Latino communities within these 15 counties.

In the 2010 – 2020 period (Table A2b in the annex), the Latino population had significant growth in these 15 counties, particularly in Sarpy (about 73%), Dodge (close to 65%), and Platte (close to 63%) counties. In eight of these counties, the growth of Latino population offset the decrease on the non-Latino population. In Lincoln and Dodge counties, this meant that without the growth of Latino population, these counties would have lost about 2,000 people each or about 6% of their population. In Hall, Dawson, Scottsbluff, Saline, and Adams counties, the population would have decreased between 1,000 and 1,500 people. Regardless of the growth of the Latino population, 4 counties: Dawson, Scottsbluff, Adams, and Lincoln counties, still had a negative population growth.

Latino Population Growth in the Omaha-Council Bluffs Metropolitan Area

We now focus on the population growth rate of the Latino and total population in the Omaha-Council Bluffs Statistical Metropolitan Area, which includes 5 counties in Nebraska (Cass, Douglas, Sarpy, Saunders, and Washington) and 3 counties in Iowa (Harrison, Mills, and Pottawattamie).




Figure 3a: Percentage Change of Latino, Non-Latino, and Total Population for the Omaha-Council Bluffs Metro Area, 1980 – 2020

Like the state level, the Latino population in the Omaha-Council Bluffs metro area grew about 706%, whereas the total population only grew 48% between 1980 and 2020 (Figure 3a and Tables 3a and 3b in the annex). Overall, the Latino population contributed by more than 31% to the growth of the Metro area. Washington County in Nebraska and Harrison County in Iowa show the largest percentage growth in this period, with more than 1,000%. However, these are also the counties with the smallest population in the Metro area. In 1980, about 55 Latinos lived in Washington and 26 in Harrison; 40 years later these populations were 619 and 293 people respectively

As of 2020, the Latino population represented 11.5% of the Omaha-Council Bluffs Metropolitan Area (Table 3 and Table A3a in the annex). About 81% of this population live in two counties, Douglas and Sarpy in Nebraska. These two are also the counties with the largest population concentration (80% of the total population).

Latinos are slightly more represented in Douglas County, where more than 72% of the Latino population in the Metro area lives. Conversely, about 59% of all non-Latinos and a little more than 60% of the total Metro population live in this county (Table 3).




Figure 2b: Percentage Change of Latino, Non-Latino, and Total Population for the Omaha-Council Bluffs Metro Area, 2010 – 2020

In the period between 2010 and 2020 the Latino population in the Metro area grew about 43%, close to four times the growth of the total population and almost 5 times the growth of the non-Latino population (Figure 2b and Table A3a in the annex). This growth contributes to about one third of the total population growth of the Metro area. Sarpy (73.4%) and Cass (62.5%) counties have the largest growth in the Nebraska side, while Harrison County (60.1%) presents the largest growth in the Iowa side. All counties in the Nebraska side have positive Latino, non-Latino and Total population growths in this period. The three Iowa counties have negative growth in the non-Latino population. The growth of the Latino population is not enough to offset the loss of population in Harrison and Mills counties, which reduced their population by 2.3% and 3.8% respectively. Pottawattamie County had a minimal total population increase of less than 1%
