COURSE INFORMATION

Description

This course provides a survey of the current knowledge base, theory and research in human sexuality with a focus on advanced practice intervention and prevention approaches for a variety of sexuality issues faced by individuals, couples, and families throughout the lifespan.

Rationale/Overview

Concerns related to sexuality and gender are common across the lifespan. However, many clinicians and social workers are unprepared to address these concerns and either avoid or inadvertently and unnecessarily pathologize these concerns. This course builds on foundational and introductory clinical coursework to provide basic knowledge, frameworks, and skills for appropriately addressing sexuality and gender issues in practice.



Course Objectives/Student Learning Outcomes

1. Consider a broad base of knowledge of human sexuality and gender and its relevance to advanced clinical practice.
2. Integrate major intervention strategies to address common sexual and relationship concerns.
3. Critique best practices, professional values, anti-racism, diversity, equity, and inclusion (ADEI), and ethics relevant to practice with LGBTQ+ individuals, couples, and families.

Students should make sure that writing assignments are free of grammar, punctuation, and spelling errors. Papers should adhere to the most recent citation style outlined by the American Psychological Association (APA).

PLAGIARISM STATEMENT

In this course, students will submit written work by making use of information and ideas found in print or online sources. Whenever material from another writer is used, it is important that students quote or paraphrase appropriately and cite the source.

The UNO Academic Integrity policy defines plagiarism as "presenting the work of another as one's own (i.e., without proper acknowledgment of the source) and submitting academic work in whole or in part as one's own when such work has been prepared by another person or copied from another person."

Failure to cite sources appropriately is plagiarism, a serious academic offense. Plagiarized work will not be accepted. Consequences for plagiarism are up to the discretion of the instructor; they may range, for example, from rewriting all or part of a paper to a grade of F for the course. Students who plagiarize more than once are subject to disciplinary action, which may include expulsion from the university.
